

ORDINANCE NO. 2021-0421A

**AN AMENDMENT TO THE ORDINANCE ESTABLISHING PARKING
REGULATIONS SECTION 7-2-4(A)**

WHEREAS, IT IS IN THE MATTER OF THE PUBLIC WELFARE OF THE CITIZENS OF THE VILLAGE OF ELIZABETH, ILLINOIS, THAT AN ORDINANCE BE ADOPTED AMENDING THE ORDINANCE TO ESTABLISH PENALTIES -SCHEDULE OF FINES IN SECTION 7-2-4(A).

WHEREAS, Section 7-2-4(A) Parking Regulations of Specific Streets reads as follows:

It is unlawful for anyone to park on the following streets in the Village:

STREET	SIDE	LOCATION	VIOLATION/ PENALTY	ORDINANCE
West Myrtle Street	North	Between Ash Street And Locust Street	Petty Offense Fine Not To Exceed \$50.00	10-13-1998
East Sycamore Street	North	From a point beginning 307 feet west of the intersection of South Madison and East Sycamore for a distance of 283 feet.	Petty Offense Fine Not To Exceed \$50.00	08-11-11

WHEREAS, The Village Board intends to approve an ordinance which will replace and add language to Section 7-2-4(A) Parking Regulations of Specific Streets and shall read as follows:

It is unlawful for anyone to park on the following streets in the Village:

STREET	SIDE	LOCATION	VIOLATION/ PENALTY	ORDINANCE
West Myrtle Street	North	Between Ash Street And Locust Street	Petty Offense Fine Not To Exceed \$50.00	10-13-1998
East Sycamore Street	North	From a point beginning 307 feet west of the intersection of South Madison and East Sycamore for a distance of 283 feet.	Petty Offense Fine Not To Exceed \$50.00	08-11-11
East Sycamore Street	North	From the point of beginning 136 feet west of intersection of Hwy 20 and East Sycamore for a distance of 185 feet.	Petty Offense Fine Not To Exceed \$50.00	4-21-21

IT IS HEREBY ORDAINED that the Village of Elizabeth approves an ordinance amending the Parking Regulations of Specific Streets, Section 7-2-4

All other terms and provisions of the original ordinance shall remain the same.
