

ORDINANCE NO. 2020-1216

**AMENDMENT TO THE ORDINANCE NUMBER 4-7-7 AND 4-7-8 THE VILLAGE OF
BED AND BREAKFAST ORDINANCE NOW TO BE KNOWN AS SHORT-TERM
HOSPITALITY RENTAL ORDINANCE.**

WHEREAS, IT IS IN THE MATTER OF THE PUBLIC WELFARE OF THE CITIZENS OF
THE VILLAGE OF ELIZABETH, ILLINOIS, THAT AN ORDINANCE BE ADOPTED

WHEREAS, Ordinance Number 4-6-7 and 4-6-8 was called The Village Bed and
Breakfast Ordinance.

WHEREAS, Section 4-6-7: reads as follows:

PROOF OF INSURANCE: The bed and breakfast establishment shall provide
proof of adequate liability insurance as required by the licensing agency.

WHEREAS, Section 4-6-8: reads as follows:

TAXES: The bed and breakfast establishment shall fulfill the requirements of the
Illinois Department of Revenue, including the payment of any applicable taxes.

WHEREAS, The Village Board intends to approve an ordinance which will replace and
add language to Chapter 7 Bed and Breakfast Ordinance, Section 4-6-7 and 4-6-8 and
shall be titled and read as follows:

The Village Bed and Breakfast Ordinance shall now be known as The Short-Term
Hospitality Rental Ordinance.

4-7-7: PROOF OF INSURANCE: The short-term hospitality rental
establishments shall provide proof of adequate liability insurance as
required by the licensing agency.

4-7-8: TAXES: All short-term hospitality rentals shall fulfill the requirements of
the Illinois Department of Revenue, including the payment of any
applicable taxes including but not limited to Jo Daviess County Hotel and
Motel Taxes.

IT IS HEREBY ORDAINED that the Village of Elizabeth approves an ordinance which
states to add language to Chapter 4-7-7 and 4-7-8, so that it shall read as follows:

The Village Bed and Breakfast Ordinance shall now be known as The Short-Term
Hospitality Rental Ordinance.

4-7-7: PROOF OF INSURANCE: The short-term hospitality rental establishment shall provide proof of adequate liability insurance as required by the licensing agency.

4-7-8: TAXES: All short-term hospitality rentals shall fulfill the requirements of the Illinois Department of Revenue, including the payment of any applicable taxes including but not limited to Jo Daviess County Hotel and Motel Taxes.

WHEREAS, The Village Board intends to approve an ordinance amending the Bed and Breakfast Ordinance and changing its name to Short-Term Hospitality Rental Ordinance.

IT IS HEREBY ORDAINED that the Village of Elizabeth approves an ordinance amending the Bed and Breakfast Ordinance to be known as Short-Term Hospitality Rental Ordinance.


All other terms and provisions of the original ordinance shall remain the same.
