

**AN ORDINANCE TO SUPPLEMENT THE APPROPRIATION ORDINANCE, FISCAL YEAR 2018-2019  
FOR THE VILLAGE OF ELIZABETH, ILLINOIS**

**ORDINANCE NO. 01162019**

**WHEREAS**, on June 20, 2018 the Village of Elizabeth passed Ordinance No. 06202018B, the Annual Appropriation Ordinance for the Village Fiscal Year beginning on May 1, 2018 and ending on April 30, 2019 (herein referred to as “Fiscal Year 2018-2019”); and

**WHEREAS**, during Fiscal Year 2018-2019 the Village of Elizabeth anticipates additional revenue from loan proceeds of \$145,000 for the purpose of improving the infrastructure of the water system.

**WHEREAS**, Ordinance No. 06202018B did not contain any appropriations for the expenditure of the purpose and program funded by the above described loan proceeds; and

**WHEREAS**, Illinois State Statute (65ILCS 5/8-2-9) allows a municipality such as the Village of Elizabeth to enact a Supplemental Appropriation Ordinance to create supplemental appropriations in an amount not in excess of the aggregate of any additional revenue available to the Village subsequent to the adoption of the Annual Appropriation Ordinance; and

**WHEREAS**, the funds of the above-described loan is “additional revenue available to the Village subsequent to the adoption of the Annual Appropriation Ordinance” as utilized in 65ILCS 5/8-2-9; and

**WHEREAS**, this Village Board finds that its creation of supplemental appropriations are in the best interests of all of the citizens of the Village of Elizabeth.

**BE IT ORDAINED BY THE VILLAGE BOARD OF THE VILLAGE OF ELIZABETH, ILLINOIS as follows:**

**Section 1.** That the Appropriations are supplemental to the appropriations contained in the Annual Appropriation Ordinance of the Village of Elizabeth for Fiscal Year beginning on May 1, 2018 and ending on April 30, 2019, commonly known as Village of Elizabeth Ordinance No. 06202018B, as amended, and are hereby appropriated for the uses and in the amounts listed below:

- A. Water Improvement Capital Projects Fund
  - i. Engineering Services (contractual services) shall be \$130,000 for plan/design of said project.
  - ii. Other Professional Services (contractual services) shall be \$15,000 for administration of said project.

**Section 2.** That all other provisions of Village of Elizabeth Ordinance No. 06202018B, as amended, except for the supplemental appropriations as described above, shall remain in full force and effect without change.

**Section 3.** This Ordinance shall be effective immediately upon its passage by the Village Board, its approval by the Village President, and its publication as provided by law.

**Section 4.** This Ordinance is expressly adopted pursuant to 65 ILCS 5/8-2-9.

**Section 5.** All ordinances or parts of ordinances in conflict with this Ordinance are repealed insofar as they conflict.

**Section 6.** If any section, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such decisions shall not affect the validity of the Ordinance as a whole or any part thereof, other than the part so declared to be invalid, and this Village Board hereby expressly declares that it would have enacted this Ordinance even with the invalid portion deleted.
