

ORDINANCE NO. 2022-0518B

**AN AMENDMENT TO THE ORDINANCE NUMBER 4-2-9 THE VILLAGE OF ELIZABETH LIQUOR ORDINANCE.**

WHEREAS, IT IS IN THE MATTER OF THE PUBLIC WELFARE OF THE CITIZENS OF THE VILLAGE OF ELIZABETH, ILLINOIS, THAT AN ORDINANCE BE ADOPTED

WHEREAS, Section 4-2-9: reads as follows:

Class A -General Liquor, on premise consumption by the glass as well as package for consumption off-premise. \$1,000.00.

Class B –All alcohol - packaged goods sales only for off-premise consumption. \$750.00.

Class C - Beer and Wine - packaged goods sales only for off-premise consumption. Also for wine/beer tasting on premises for which remuneration may or may not be received - \$500.00.

Class D – Beer, wine and liquor on-premise consumption by the drink only. Special event license. \$25.00 for the first day. Each additional consecutive day \$25.00. Date(s) for license requested.

Class E- “Event Liquor License” for sales of locally produced beer, wine and liquor sold in packaged form. \$25.00 per day.

WHEREAS, The Village Board intends to approve an ordinance which will replace and add language to Chapter 4, Liquor Control, Section 4-2-9 and shall read as follows:

Class A -General Liquor, on premise consumption by the glass as well as package for consumption off-premise. \$1,000.00.

Class B –All alcohol - packaged goods sales only for off-premise consumption. \$750.00.

Class C - Beer and Wine - packaged goods sales only for off-premise consumption. Also, for wine/beer tasting on premises for which remuneration may or may not be received - \$500.00.

Class D – Beer, wine and liquor on-premise consumption by the drink only. Special event license. \$25.00 for the first day. Each additional consecutive day is \$25.00. Date(s) for license requested.

Class E- "Event Liquor License" for sales of locally produced beer, wine and liquor sold in packaged form. \$25.00 per day.

— Class H- Bring your own beer and wine on the premises; Fee \$250.00.

IT IS HEREBY ORDAINED that the Village of Elizabeth approves an ordinance which states to add language to Chapter 4-2-9, so that it shall read as follows:

Class A - General Liquor, on premise consumption by the glass as well as package for consumption off-premise. \$1,000.00.

Class B - All alcohol - packaged goods sales only for off-premise consumption. \$750.00.

Class C - Beer and Wine - packaged goods sales only for off-premise consumption. Also, for wine/beer tasting on premises for which remuneration may or may not be received - \$500.00.

Class D - Beer, wine and liquor on premise consumption by the drink only. Special event license. \$25.00 for the first day. Each additional consecutive day is \$25.00. Date(s) for license requested.

Class E- "Event Liquor License" for sales of locally produced beer, wine and liquor sold in packaged form. \$25.00 per day.

Class G- For use of businesses other than bars/taverns that would like gaming machines. Allows beer/wine to be sold and consumed on premises. Packaged goods sales for off-premises consumption only. \$500.00.

Class H- Bring your own beer and wine on the premises; Fee \$250.00.

WHEREAS, The Village Board intends to approve an ordinance amending the liquor ordinance.

IT IS HEREBY ORDAINED that the Village of Elizabeth approves an ordinance amending the liquor ordinance.

All other terms and provisions of the original ordinance shall remain the same.
